In Q2 through Q4 we pivoted our approach, in partnership with Participate, to provide a virtual certification, focused on mathematics and social justice, for US teachers. We also presented 10 educational webinars and resources focused on global mathematics education to a virtual community. These resources are freely available and publicized on our website and Facebook page.**4b** (Code: ) (Expenses \$ 191,511 including grants of \$ 0) (Revenue \$ 0)2. International Professional Development From January to March we provided in person support to 146 teachers through master classes, conferences and in-classroom coaching. In April we shifted to fully virtual support due to the pandemic and developed new virtual programs. Despite the pandemic we are able to continue to provide alternative ways of understanding and solving mathematical tasks allowing teachers to learn about new ways to empower their students as critical thinkers. Through these newly developed virtual programs and our existing education resources - Global Math Stories - we supported 207 teachers with 172 hours of professional development. Our virtual conferences and bespoke programs also provided local leadership opportunities for teachers to design and facilitate workshops for their peers.**4c** (Code: ) (Expenses \$ 44,705 including grants of \$ 0) (Revenue \$ 0)3. Community Outreach. Due to the pandemic in 2020 our community outreach grew to encompass both US and international teachers. Teachers across the globe were able to connect with our resources, presentations and discussions. In 2020 we produced 34 hours of live content that are accessible for free online. We also published 15 high quality resources for teachers in both English and Spanish that are freely available for download and immediate use in the classroom, whether virtual or in-person. Facebook discussions and mathematics presentations.
